If you are a junior and wish to ride senior bulls you may do so with the approval of your parents, stock contractor, arena director, once you move up you cannot move back down.
3. Barrel Racing, Pole Bending, Goat Tying, Breakaway Roping, Tie Down Roping & Dally Team Roping ages: Tots 8 and under, juniors 9-13 yrs, seniors 14-17 yrs.
4. Fees are \$20.00 - \$5.00 will be put in a jackpot per event.

Dear Parents:

Here are two items that I would like to bring to your attention:

1. HORSE HEALTH PAPERS - Please ask your Vet to prepare health papers (Coggins) on your horse. These papers should be kept with you in case one of the AYRA RODEOS this year is inspected by the State.
2. MEDICAL CONSENT FORMS – If you are unable to attend a rodeo, in which your child is participating, please make sure that you fill out and send a medical consent form. This form should be given to the “Responsible Party” who is in charge of your child during the rodeo. This form will be necessary in case of a medical emergency. This is only a precaution and I hope it will never be needed.

## RELEASE OF LIABILITY, INDEMNITY AND AGREEMENT NOT TO SUE

- 1. ASSUMPTION OF RISK:** I know and understand the full and complete scope, nature, and extent of the risks involved in entering Arcadia Youth Rodeo Association events and engaging in the associated activities and that such risks have been identified and explained to me and that other dangers relative, thereto cannot be foreseen or otherwise contemplated. I understand that there are certain risks and dangers inherent in entering the events and otherwise engaging in the Activity and that by entering onto the Rodeo grounds and/or otherwise engaging in the activities, I am subjecting myself to the possibility of loss of life, disfigurement, serious bodily injury, and damage to my person as well as loss to my personal property and effects. Having carefully considered these risks, I voluntarily, freely, without coercion, and duress, choose to assume and all such risks and take responsibility therefore and for my actions and the actions of my invitees while on or about the Rodeo grounds and otherwise engaged in the Activity [\_\_\_\_\_] please **initial here.**
- 2. RELEASE OF LIABILITY:** I hereby release and discharge Arcadia Youth Rodeo Association, Inc. Should any such lawsuit or cause of action or claim be instituted against any of the Releases, I agree that such Releases shall be entitled to recover attorney's fees and costs incurred in the defense of such lawsuit or cause of action, including any arising there from.
